A BILL ENTITLED CHR 3-2024 SHORT-TERM RENTAL TAX

SECTION 1. NOW THEREFORE BE IT ENACTED BY THE COUNTY COMMISSIONERS OF KENT COUNTY, MARYLAND that Chapter 152, Taxation is hereby amended by repealing Chapter 152 Taxation, Article III Hotel Rental Tax, and reenacting with amendments Chapter 152 Taxation, Article III Short-Term Rental Tax herein.

ARTICLE III Hotel SHORT-TERM Rental Tax

§ 152-16 Establishment AND DEFINITIONS.

The Board of County Commissioners may impose, by resolution, a tax on a transient charge paid to a hotel **SHORT-TERM RENTAL** located in Kent County as authorized by and consistent with the provisions of the Annotated Code of Maryland, Article 24, Title 9, Subtitle 3, Part I LOCAL GOVERNMENT **ARTICLE § 20-403**.

AS USED IN THIS ARTICLE, THE FOLLOWING WORDS HAVE THE MEANING INDICATED:

- A. "SHORT-TERM RENTAL" MEANS AN ESTABLISHMENT THAT OFFERS SLEEPING ACCOMMODATIONS FOR COMPENSATION AS DEFINED IN THE ANNOTATED CODE OF MARYLAND, LOCAL GOVERNMENT ARTICLE § 20-401 AND 152-16 OF THIS CODE.
 - 1. "SHORT-TERM RENTAL" INCLUDES, BUT IS NOT LIMITED TO:

(A) AN APARTMENT;
(B) A COTTAGE;
(C) A HOSTELRY;
(D) A HOTEL
(E) AN INN;
(F) A MOTEL;
(G) A ROOMING HOUSE;
(H) A TOURIST HOME;
(I) A RESIDENTIAL RENTAL, INCLUDING THOSE FACILITATED BY A HOSTING PLATFORM OR BOOKING SERVICE, OR
(J) AN OUTDOOR RETREAT

B. "SHORT-TERM RENTAL TAX" MEANS A TAX ON A TRANSIENT CHARGE.

- C. "TRANSIENT CHARGE" MEANS A CHARGE FOR SLEEPING ACCOMMODATIONS FOR A PERIOD NOT EXCEEDING 4 CONSECUTIVE MONTHS BUT DOES NOT INCLUDE ANY CHARGE FOR SERVICES OR ACCOMMODATIONS OTHER THAN SLEEPING ACCOMMODATIONS.
- D. "OWNER OR OPERATOR" MEANS A PERSON WHO POSSESSES OR HAS AN OWNERSHIP INTEREST IN A SHORT-TERM RENTAL OR IS ENGAGED IN THE BUSINESS OF OPERATING SHORT-TERM RENTALS.
- E. "COLLECTING AUTHORITY" MEANS THE COUNTY CHIEF FINANCE OFFICER.
- F. "COUNTY" MEANS KENT COUNTY, MARYLAND, OR THE COUNTY COMMISSIONERS OF KENT COUNTY, MARYLAND.

§ 152-17 Payment; collection; distribution RETURN.

The procedures set forth in § 9-301 et seq of Article 24 of the Annotated Code of Maryland shall be followed. These provisions control the payment, collection, and the distribution of the taxes so collected.

THE FOLLOWING PROCEDURES CONSISTENT WITH § 20-406 *ET SEQ*. OF THE LOCAL GOVERNMENT ARTICLE OF THE ANNOTATED CODE OF MARYLAND SHALL BE FOLLOWED.

- A. THE SHORT-TERM RENTAL, OWNER, OR OPERATOR SHALL GIVE A PERSON WHO IS REQUIRED TO PAY A TRANSIENT CHARGE A BILL THAT IDENTIFIES THE TRANSIENT CHARGE AS A SEPARATE ITEM FROM ANY OTHER CHARGE AND COLLECT THE SHORT-TERM RENTAL TAX FROM THE PERSON WHO PAYS THE TRANSIENT CHARGE.
- B. A PERSON SHALL PAY THE SHORT-TERM RENTAL TAX TO THE SHORT-TERM RENTAL, OWNER, OR OPERATOR WHEN THE PERSON PAYS THE TRANSIENT CHARGE.
- C. THE SHORT-TERM RENTAL TAX SHALL BE HELD IN TRUST BY THE SHORT-TERM RENTAL, OWNER, OR OPERATOR UNTIL REMITTED TO THE COUNTY AS REQUIRED BY THIS ARTICLE.
- D. A SHORT-TERM RENTAL, OWNER, OR OPERATOR SHALL COMPLETE, SIGN, AND FILE A SHORT-TERM RENTAL TAX REPORT, ON THE FORM AND IN THE MANNER THE COUNTY REQUIRES AND REMIT THE FULL TAX DUE ON OR BEFORE THE 21ST DAY OF EACH MONTH FOR THE PRECEDING MONTH.

- E. THE REMITTER OF THE SHORT-TERM RENTAL TAX, FOR ADMINISTRATIVE COSTS, MAY RETAIN 1.5% OF THE GROSS AMOUNT OF SHORT-TERM RENTAL TAX COLLECTED IF, ON OR BEFORE THE DUE DATE, THE SHORT-TERM RENTAL:
 - 1. FILES A COMPLETED SHORT-TERM RENTAL TAX REPORT; AND
 - 2. PAYS THE SHORT-TERM RENTAL TAX TO THE COUNTY.
- F. IF A SHORT-TERM RENTAL, OWNER, OR OPERATOR FAILS TO PAY THE SHORT-TERM RENTAL TAX AS REQUIRED ABOVE, THE SHORT-TERM RENTAL, OWNER, OR OPERATOR SHALL PAY 0.5% INTEREST ON THE UNPAID TAX FROM THE DATE WHICH THE TAX WAS DUE UNTIL THE DATE THE TAX IS PAID.
- G. IF A SHORT-TERM RENTAL, OWNER, OR OPERATOR FAILS TO PAY THE SHORT-TERM RENTAL TAX WITHIN 1 MONTH AFTER THE PAYMENT IS DUE, THE SHORT-TERM RENTAL, OWNER, OR OPERATOR SHALL PAY A TAX PENALTY OF 10% OF THE UNPAID TAX.

§ 152-18 Disposition of revenue DISTRIBUTION AND OTHER REGULATIONS.

All revenue generated to the county by this tax is to be used exclusively for economic development and tourism efforts on behalf of Kent County.

A. ALL REVENUE GENERATED BY THE SHORT-TERM RENTAL TAX SHALL BE DISTRIBUTED BY THE 30TH DAY OF THE CALENDAR MONTH AS FOLLOWS:

- 1. FOR A SHORT-TERM RENTAL PROPERTY LOCATED IN A MUNICIPALITY:
 - (A) 10% TO THE GENERAL FUND OF THE COUNTY FOR THE ADMINISTRATIVE COSTS OF COLLECTION OF THE TAX; AND
 - (B) 90% TO THE MUNICIPALITY IN WHICH THE SHORT-TERM RENTAL PROPERTY IS LOCATED.
- 2. FOR A SHORT-TERM RENTAL PROPERTY LOCATED OUTSIDE OF THE CORPORATE BOUNDARIES OF A MUNICIPALITY: 100% TO THE GENERAL FUND OF THE COUNTY.

- B. THE COUNTY COMMISSIONERS MAY ADOPT REGULATIONS CONSISTENT WITH TITLE 20 OF THE LOCAL GOVERNMENT ARTICLE OF THE ANNOTATED CODE OF MARYLAND, AND TITLE 11 OF THE TAX-GENERAL ARTICLE OF THE ANNOTATED CODE OF MARYLAND, TO PROVIDE ORDERLY, SYSTEMATIC, AND THOROUGH ADMINISTRATION OF THE SHORT-TERM RENTAL TAX.
- C. SHORT-TERM RENTALS AS DEFINED ABOVE IN §152-16 A. 1., SHALL BE IN ALL COUNTY AND MUNICIPAL REGULATIONS, COMPLIANCE WITH LICENSING, AND ORDINANCES, WHERE APPLICABLE, TO INCLUDE BUT NOT LIMITED TO MEMORANDUMS OF UNDERSTANDING, FEE STRUCTURES. ADOPTED REGULATIONS, AND LAND USE ORDINANCE(S).

SECTION 2. BE IT FURTHER ENACTED by the County Commissioners of Kent County that this

Act shall take effect on the 1st day of July 2024.

I am writing to request that the County Commissioners review and approve an increase to our current fee schedules for the Environmental Health program. These fees have not been updated in over 16 years and have not kept pace with our operating expenses. To ensure that the proposed increases are comparable to our neighbors, we surveyed what they charge and provide the current range of prices for reference. In situations where our proposed fee is higher than others, this typically reflects a low volume service that entails significant effort to complete.

If the Commissioners approve I seek to implement the new schedule on July 1, 2024.

Attached you will find two (2) schedules of fees: 1) Environmental Health Fees and 2) Building Permit fees.

I look forward to discussing this request with the Commissioners and answering any questions they may have. I believe these fees represent a fair value for our citizens while ensuring the Health Department can continue to protect the citizens of Kent County.





RE: The Maryland Senior Citizens Hall of Fame, Inc., Hall of Fame Nomination

Dear Sir or Madam:

Philip Cicconi has been a volunteer in Kent County Maryland since moving here in 1998. Almost immediately after moving to Kent County, he joined the Friends of Eastern Neck National Wildlife Refuge where he served as a Board member, Vice President, and President until resigning in 2021. During his tenure as President, he led a successful effort in 2018 to keep the refuge open despite the fact, that closure was considered a forgone conclusion. This was accomplished through persistence, meetings with Maryland politicians, and numerous letters written and data collection. His success allowed the maintenance of a wildlife refuge to support thousands of migrant birds, maintain healthy waterways, and prevent erosion. In addition, the refuge now remains financially beneficial to the County and the Town of Rock Hall through increased tourism.

Another of Phil's major achievements is the organization of the Kent County Learning Center, Inc. Utilizing his business background, he completed the incorporation and the establishment of the 501 (c)(3). Then, he volunteered as a tutor, initially to help seventy-eight Rock Hall watermen earn a high school diploma through the General Education Diploma (GED) program. Watermen found that making a living on the water was no longer feasible, but they were limited in their ability to get other jobs due to the lack of a high school diploma. After meeting the need for high school diplomas, as a Vice President, he assisted in redirecting the Learning Center's purpose to improving elementary student achievement. The goal was to help students get a good math foundation so all Rock Hall students would earn a high school diploma, thus, eliminating the need for the GED classes. This program provides one-to-one tutoring for students in grades one to five. The program has been active since 2014 and utilizes approximately twenty-five volunteers each year. This year, Rock Hall Elementary was the only county school to grow in reading and math at each grade level. Several grade levels achieved proficiency levels above the state levels.

The above accomplishments earned Phil a reputation as a problem solver and that accelerated his volunteer accomplishments. Phil's service as a member of the Kent County Commission on Aging directed most of his recent volunteering toward senior issues. For example, during COVID-19, seniors were unable to obtain vaccines due to limited quantities and a lack of technological proficiency.

To solve the problem, Phil worked with the Kent County Health Department to set aside a specific number of vaccines for seniors. Then, a team from the Kent County Commission on Aging called and registered 1200 Kent County seniors for both recommended vaccinations. This alone made him a hero to Kent County seniors.

Currently, he is working with Rock Hall and Kent County leaders to assist elderly citizens in avoiding offshore scams by speaking to churches and other groups and distributing custom-written documents warning of scams and describing how to avoid them.

Another new and exciting initiative is the promotion of Financial Literacy as a graduation requirement in the Kent County Public Schools. Phil began promoting Financial Literacy because many seniors were living solely on Social Security and needed significant financial help. Initially, Phil was faced with opposition because Financial Literacy does not help current seniors. However, Phil, a systems thinker, continued to promote the idea at each opportunity for the last couple of years. He continued to communicate his goal of helping meet the needs of current seniors but also, eliminating the same problem for the next generation of seniors. Financial Literacy is becoming increasingly important in our daily lives as these concepts are becoming more complex and difficult to understand and social security and pensions for future generations are less certain.

In Rock Hall, if a senior has a problem, call Phil. He is known for his caring attitude, large network of contacts, and incredible insight and persistence. It is without reservation that we recommend Phillip Cicconi for the 2024 Maryland Senior Citizen's Hall of Fame.

Choptank Health partners with Kent County Public Library to expand access to behavioral health

Choptank Community Health is expanding access to healthcare for behavioral health patients in Kent County through a new partnership with the Kent County Public Library (KCPL) and its Chestertown and North County branches to provide safe spaces and the use of iPads for telehealth appointments.

The program is funded through a grant from the Mid-Shore Health Improvement Coalition and aims at providing expanded access to healthcare to people without access to technology, including those in Mid-Shore's most rural areas.

"We're especially grateful for this new partnership with Kent County Public Library and the Coalition's funding because it helps to expand access to healthcare, and that's something we are deeply committed to at the core of our mission," says Choptank Health President and CEO Sara Rich.

"That's why we are investing in innovative ways to reach our patients closer to where they are, including increased access to mobile medical services and telehealth appointments, like this program with the library, which we hope we can replicate in other Mid-Shore areas."

Rich says behavioral health patients will need to make appointments with Choptank Health before using the iPads. When arriving at the Chestertown or North County library branches, patients will be provided with an iPad and a safe space in a Cubicall study pod to conduct video appointments with their Choptank Health provider.

Cubicall is a U.S.-based company that provides modular spaces for isolated, private communications in healthcare offices, libraries, court systems, businesses, and more.

The iPads will be returned to the library's front desk at check out for others to use after each session. The installation of the Cubicall study pods at KCPL's Chestertown and North County branches in 2023 was made possible in part by the Institute of Museum and Library Services, IMLS Grant #00001386. IMLS is the primary source of federal support for the nation's libraries and museums.

"The library is a community resource for our residents to use for more than just books," said Kent County Public Library Executive Director Arnessa Dowell. "We're proud to partner with Choptank Health on this project to help strengthen our communities and help bring this access to healthcare to Kent County."


