Shelley Neal-Edwards, Director of Social Services, requested a certificate of

appreciation for Ms. Tracye Landon, who worked as a Family Caseworker in the Human Services Department for forty-one (41) years and will retire effective November 8, 2024. Mr. Yeager read the certificate of appreciation into the record and presented it to Ms. Landon. The following Human Services Staff members were in attendance: Shelly Neal-Edwards, Nikki Strong, Kathryn McAllister, Christina Russell, Mattie Meehan, Taylor Nickerson, Amanda Plummer, Lakala Whaley, Alison Farmer, Sandy Richardson, Susan Caulk, Rachel West, Margaret Allen, Lindsay White, and Patty Dahle.

APPOINTMENTS

Kent County Public Schools: Tom Porter, Supervisor for Accountability and Career and Technical Education (CTE) at Kent County Public Schools, provided an overview and presentation of the Career and Technical Education Technology Programs offered at Kent County High School. Commissioner Price asked if Electrical and Plumbing courses could be offered. Mr. Porter stated those courses could be added; however, multiple factors come into play when creating a new CTE program. New instructors could cost as much as \$100,000.00. The staff has been researching alternatives such as dual enrollment with Chesapeake College and apprenticeships with local businesses.

A Kent County resident, Mike Waal, asked if the High School offered a financing course. Mr. Porter stated that the Academy of Finance Course is not currently offered. An introduction to business and a finance course is offered.

<u>Chester Valley Ministers Association:</u> Terwana Brown, President of the Chester Valley Ministers Association, provided an update on the Good Neighbor Fund Initiative. Commissioner Fithian requested a work session to be scheduled with the Chester Valley Ministers Association, the Department of Social Services, and other partners in Kent County to discuss the county's needs.

KENT COUNTY DETENTION CENTER

Roland Sheppard, Acting Director of Operations, and Steve Wallace, Captain of the Kent County Detention Center, requested acceptance of the University of Maryland Psychiatry Associates, P.A. (UMPA) agreement to provide telehealth services for the Medication Assisted Treatment (MAT) and Substance Use Disorder (SUD) programs required by state mandate. In 2019, Maryland passed HB-116, which mandates each detention center to provide MAT to Incarcerated Individuals in their custody. Kent County has implemented this initiative with the help of State grants. For FY2025 funding, Kent County was awarded \$226,396.00 from the Performance Incentive Grant Fund (PIGF). Kent County's program provides screening, referral, counseling, and treatment through medication for those with SUDs and fulfills the requirements outlined in the Annotated Code. For the past two years, Kent County has partnered with the UMPA to provide telehealth services that include evaluation and treatment of patients, charting, writing orders, phone consultation with nursing staff, writing bridge prescriptions, and similar services. During that same time, staff used another provider, Maryland Treatment Center (MTC), for telehealth counseling. MTC was the only provider at the time that would provide a

quote for these services. However, for FY2025, UMPA has also provided a quote for telehealth counseling. UMPA's quote is \$13,750.00, which is lower than MTC's quote for Y2025. UMPA has provided quality services to date. Mr. Sheppard and Captain Wallace recommended using UMPA as the telehealth counseling provider for FY2025. If the attached agreement is approved and UMPA provides all contractual services, the PIGF grant of \$85,085.00 will fully fund the services. The remainder of the grant funds will be used for nursing, peer recovery, and medication costs. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved to have University of Maryland Psychiatry Associates, P.A. provide the telehealth services for the Medication Assisted Treatment and Substance Use Disorder Program as required by state mandate.

PARKS AND RECREATION

Jill Coleman, Director of Parks and Recreation; Carrie Klein, Deputy Director, Public Works; Dan Small, Associate Director, Natural Land Stewardship Center for Environment & Society; and Katherine Thornton, Field Technician, Natural Lands Project, Washington College, gave an overview of the Turner's Creek & Toal Park Farmland Project proposal. In January 2023, the Director of Parks and Recreation received an email from Michael McQuarrie at the Department of Natural Resources (DNR) confirming that no agricultural work is permitted on properties funded by the Program Open Space (POS), which includes Turner's Creek and Toal Park Property. Staff had been in communication with Dan Small, Associate Director of the Natural Land Stewardship Center for Environment & Society at Washington College. They focus on the Natural Lands Project, which collaborates with landowners to convert marginal cropland into wildlife habitats. This project primarily involves planting diverse native meadows to support grassland wildlife, particularly the Northern Bobwhite, and overseeing wetland restorations and large tree plantings for woodland species. The initiatives are grant-funded, covering all costs for habitat installations and management for three years. The Department of Public Works will maintain a natural Walking Trail outside the native meadow plantings. The Washington College staff will work closely with the Department of Public Works to manage and oversee these efforts. The Turner's Creek & Toal Park project proposal was presented to the Parks and Recreation Advisory Board (PRAB), which favors advancing this initiative. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved the advancement of the Turner's Creek & Toal Park project, along with the dedication of the Turner's Creek Project to a Kent County native, whose name will be announced at a later date. A letter of support for Washington College was signed.

KENT FAMILY CENTER

Katie LeMaire, PhD Child Development Specialist, on behalf of Lisa Mazingo, Director of Kent Family Center, requested an extension from Maryland Family Network for the FY2024 grant period. The grant period for the FY2024 award was extended from June 30, 2024, to September 30, 2024. Discussion took place. On a motion made by Commissioner Price and

seconded by Commissioner Nickerson, the Commissioners unanimously approved and signed the extension of the FY2024 MFN grant from June 30, 2024, to September 30, 2024.

HUMAN RESOURCES

Jim Miller, Director of Human Resources, requested approval to offer the Compensatory Time Buy-Back program to the County employees. Compensatory Leave (Comp Time) is time accrued by staff instead of being paid overtime. Non-exempt employees are those who are working more than forty (40) hours a week. For exempt employees, it is for working on weekends or in the event of an emergency or special circumstances, with approval, for hours worked on Monday-Friday. For deputies and correctional officers sworn in, it is for working more than 85.5 hours in a pay period. The maximum accrual is eighty (80) hours. For the past seven (7) years, employees have been granted permission to sell back to the County a maximum of forty (40) hours of compensatory leave. In 2023, twenty-four (24) employees sold back compensatory leave hours to the County, totaling \$23,528.05. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved the County Compensatory Leave Buy-Back Program for employees to sell back to the County a maximum of forty (40) hours of compensatory time. Payment is to be made with the paycheck of November 25, 2024.

Mr. Miller requested approval to hire the recommended candidate for the Emergency Medical Technician (Full-Time) vacancy. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved a conditional offer of employment to the recommended candidate.

Mr. Miller requested approval to hire the recommended candidate for the Grant Program Administrator vacancy. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved a conditional offer of employment to the recommended candidate.

Mr. Miller announced, under the advisement of Commissioner Fithian, that the County Appreciation Dinner will be held this year at the Rock Hall Volunteer Fire Company on December 14, 2024.

PUBLIC WORKS

Environmental Operations Division- Authorize Purchase of Roll-Off Truck: Dan Mattson, Director of Public Works, requested authorization to purchase a Galbreath U75-OR-174 75000# Outside Rail Tandem-Axle Roll-Off Hoist. Discussion took place. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved the purchase of a Galbreath U75-OR-174 75000# Outside Rail Tandem-Axle Roll-Off Hoist from Mid-Atlantic Waste Systems under the state contract for \$289,410.00.

Public Works Update: Mr. Mattson updated various projects that are in progress.

- Worton Park Multipurpose Courts County staff is wrapping up the topsoil application and stabilization.
- <u>Emergency Services Building</u> Staff are scheduled to meet with the Town of Chestertown on Wednesday, October 23rd, to request the grading permit. They should have it by the end of the week.
- <u>Bayside Landing</u> The project is out to bid. The County could receive over \$500,000.00 from the Department of Natural Resources.
- <u>Nicholson Groundwater Treatment</u> Pilot Testing and permit revisions are underway.
- <u>The Worton Sludge Press Replacement</u> The project bid is open. ARPA funds will be used for the purchase.

COUNTY ADMINISTRATOR

By the end of 2024, the Commissioners will have met and held thirty-nine (39) meetings, seven (7) of which were work sessions. The scheduling model modifies the meeting schedule to account for conference weeks and holidays. The proposed 2025 calendar follows the same model and will make the proper adjustments for meeting consistency. Budget work sessions will be added when the dates are available to staff. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved accepting the 2025 meeting calendar as recommended by staff.

LETTER FOR SIGNATURES

Commissioners signed a Thank You for Your Interest Letter addressed to Jonathan Quinn. Mr. Quinn submitted an interest form for the Planning Commission.

PUBLIC COMMENT

The procedures for public comment were in effect. The public offered no comments.

A letter was received from Andy Fish, Senior Director, Office of Finance Programs, Maryland Department of Commerce, addressed to Commissioner Fithian. Mr. Fish notified the Commissioners of the County's Private Activity Bond allocation share. The unused allocation reverts to the Department and is placed in the Secretary's Reserve. The letter was available for review and included the Exhibit A report.

A letter was received addressed to Dr. Mary Boswell-McComas, Kent County Public Schools, Superintendent, from Donna Gunning, Assistant State Superintendent, Division of Financial Planning, Operations, and Strategy, Maryland State Department of Education, was copied to Shelley Heller, County Administrator. Ms. Gunning informed Dr. McComas that the
