# PUBLIC HEARING – RESOLUTION 2024-14 AMENDED, RESOLUTION AND DECISION TO GRANT GROWTH ALLOCATION FOR THE REFERENCED AREAS ON THE NEW ZONING MAP

A public hearing was held to discuss granting new growth allocation for an additional item related to the rezoning properties already indicated on the adopted Zoning Map as a new Marine (M) at Haven Harbour South in Rock Hall. Public information regarding the abovementioned hearings and minutes is posted on the County's website at <a href="https://www.kentcounty.com/commissioners/meeting-agenda">https://www.kentcounty.com/commissioners/meeting-agenda</a>.

#### KENT COUNTY DETENTION CENTER

Captain Steve Wallace of the Kent County Detention Center (KCDC) discussed a treatment agreement. The University of Maryland Medical Center provides professional and pharmaceutical services for the Medication Assisted Treatment (MAT) Program and provides methadone as an alternate treatment for Incarcerated Individuals. All funds for this will be reimbursed to the County from the Performance Incentive Grant Fund (AKA Justice Reinvestment Fund). Captain Wallace informed the Commissioners that the contract needed to be revised due to the incorrect breakdown of fees. Mr. Yeager stated that the Commissioners could approve and sign the contract contingent upon receiving a revised contract and that the County will not release the signed contract until a revised contract has been received. Discussion took place. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved the Agreement between the University of Maryland Medical Center and Kent County Detention Center for the Medication Assistance Treatment Program to be covered by the Performance Incentive Grant Fund contingent upon receiving a revised copy of the contract as presented.

#### ECONOMIC AND TOURISM DEVELOPMENT

Jamie Williams, Director of Economic and Tourism Development, requested approval of a Letter of Intent for Incentives with Avail Enclosure Systems, which includes a Maryland Economic Development Assistance Fund (MEDAF) Conditional Loan requiring a local match. Avail Enclosure Systems is located in Millington on the Queen Anne's County side, 3011 Millington Road. It was founded in 1989 as Power Electronics, Inc. and acquired in 2016, leading to the formation of Avail Enclosure Systems. The facility at 31850 Millington Road (old Infinity Recycling building) off of U.S. 301 will allow the company to move the smaller jobs, relays, and control panels to meet the growing demand for their products. The Commerce MEDAF conditional loan of \$200,000.00 (which becomes a grant if all conditions are met) with a 10% (\$20,000.00) required local match will create forty-five new jobs in Kent County. Avail will maintain the 117 jobs in Queen Anne's County and create 45 new jobs in Kent County by December 17, 2027. The Letter of Intent is not binding; it is the proposed State and County assistance for the project. Loan documents from Commerce will need to be prepared and executed. The funding can be included and approved in the FY2026 budget. Discussion took place. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved and signed the Letter of Intent for Incentives for Avail to include a MEDAF Conditional Loan, which requires a 10%, \$20,000.00 local match that will be addressed with the FY2026 Budget.

#### **HUMAN RESOURCES**

Jim Miller, Director of Human Resources (HR), requested the approval of a new Employment Agreement for a recently hired Senior Staff employee. Employee Agreements automatically renew effective January 1<sup>st</sup> of every year. Discussion took place. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved the attached employment agreement for the calendar year 2025.

Mr. Miller and Rachel Morlock, HR Administrative Specialist, requested approval to hire the recommended candidate to fill the Kent Family Center child development teacher (parttime) vacancy. Discussion took place. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved a conditional offer of employment to the recommended candidate to fill the vacancy.

Commissioner Price requested that the Employee Appreciation Dinner survey results be provided to the Commissioners for review.

### **COUNTY ADMINISTRATOR**

Shelley Heller, County Administrator, requested the Board approve and sign an in-kind response letter. Deborah Voshell wrote a letter to the Commissioners regarding her quarter utility bill for water and sewer. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved to sign the in-kind response letter addressed to the resident as drafted.

Kent County Public Library (KCPL) – Library of Trustees Board: Robert Bell, Executive Director of the KCPL, was introduced by Ms. Heller to the Commissioners. The Board of Library Trustees will have two vacancies as of January 2025. The terms of the two trustees ended as their tenure in the position expired. The Board recruited widely for Trustee applicants, publishing details on the library website and in local papers. The Board of Trustees submitted its nominations. Letters for Jay Silcox and Amy Sine were also drafted for signatures, thanking both trustees for their service. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously appointed Clara Rankin and Deborah Westerland to serve on the Board of Library Trustees for a 5-year term ending December 31, 2029.

Commissioner Price requested that Pat Merritt, the Chief Finance Officer, review Mr. Waals's numbers to determine what the County can do to reduce the burden on Kent County residents. Ms. Heller announced that Kent County residents are urged to file a Homestead Credit application with the Finance department to offset the annual tax increases. Residents are urged to file an appeal should they feel their property taxes are too high.

Carol Niemand, President of The Shelter Alliance, updated the Commissioners on the organization's work. The organization still needs a building to house homeless families and individuals.

#### **ADMINISTRATIVE HEARING**

The administrative hearing began at 1:08 p.m. Thomas N. Yeager, the County Attorney, outlined the protocol for the hearing. Mr. Yeager administered the Oath to Bonnie S. Pearsall, Inspector, Kent Alcohol and Tobacco Enforcement (KATE), for testifying. The rules for an administrative hearing were in effect.

This is the continuation of an administrative hearing held on December 3, 2024, regarding the failure of Coleman's Tavern to obtain its 2024 trader's/business license. At the hearing, Mr. Yeager advised the Board that in past cases, hearings were continued to allow licensees time to obtain necessary approvals. If a valid license is presented, the hearing will be canceled. The Board agreed to postpone the hearing until January 7, 2025. Due to inclement weather, the Administrative Hearing was rescheduled for January 9, 2025, at 1:00 p.m. Coleman's Tavern has still not obtained a trader's/business license and has remained non-compliant since the renewal of its alcoholic beverage license in April. On November 7, 2024, Bonnie S. Pearsall, Inspector, Kent Alcohol and Tobacco Enforcement (KATE), issued and hand-delivered a written warning to Carolyn Jones, President/Treasurer, Coleman's Tavern, regarding the absence of the license. Mr. Yeager stated that the Licensee has had complications with the Comptroller of Maryland regarding personal property taxes.

Inspector Pearsall reported that Ms. Jones has been collaborating with the Economic and Tourism Development Department to address the ongoing issue. She has been working diligently

and making sincere efforts to resolve the situation. Ms. Jones indicated that the personal property taxes for 2024 and 2025 have now been filed and are awaiting a clearance letter from the Comptroller's Office. Once she receives the clearance letter, Ms. Jones can file articles for revival. Mr. Yeager recommended postponing the Administrative Hearing until the beginning of March. On a motion made by Commissioner Price and seconded by Commissioner Nickerson, the Commissioners unanimously approved to extend the Administrative Hearing until March 4, 2025, to give the Licensee a chance to work with the Comptroller's Office to straighten everything out.

The Administrative Hearing concluded at 1:15 p.m.

At 2:42 p.m., a motion was made by Commissioner Nickerson, seconded by Commissioner Price; the Commissioners unanimously agreed to adjourn the meeting. The Board is scheduled to meet again on Tuesday, January 28, 2025, at 10:00 a.m.
